B. PROPOSED FY-2022 AGENCY BUDGET.

D. GLOBAL GAMING RP, LLC'S REQUEST FOR APPROVAL OF MORTGAGE REFINANCE OF REMINGTON PARK LEASEHOLD ESTATE AND PLEDGE OF REMINGTON PARK ASSETS

Background

Remington Park's racing license Order requires Commission written approval before Global Gaming RP, LLC can sell, transfer, lease, sublease or otherwise affect any interest in the real property of the racetrack.

Current Consideration

The Commission received a request from Jared Easterling, Esq., counsel for Global Gaming Solutions, LLC, the sole member of Global Gaming RP, LLC [Remington Park] to be placed on the agenda. Global Gaming is seeking to refinance its loan with Wells Fargo. The underlying debt will be an amount not to exceed \$92,500,000.00.

E. RECOMMENDATION FROM THE OKLAHOMA-BRED ADVISORY COUNCIL.

Background

The Oklahoma Bred Advisory Council met on May 5th to discuss funding recommendations for the 2021- 2022 Calendar and Fiscal Years. Recommendations are as follows:

- 1. Renewal of Veterinary Medical Diagnostic Program & Necropsy Study The Oklahoma-Bred Advisory Council unanimously recommends to the Commission that the Necropsy Study funds be replenished to return the budget to \$50,000 for FY 2022.
- The Oklahoma- Bred Council Requests Funding for CY 2022 Year- End Oklahoma Bred Champion Trophies of Up To \$15,000-Combined For All Breeds.
- 3. The Oklahoma-Bred Council Requests Funding for CY 2022 (Promotional Advertising of the Program in Industry Publications of up to \$50,000. The Advisory Council unanimously recommends Commission approval of funding for the annual promotional advertising of the Program in industry publications with up to \$25,000 for the Quarter Horse, Paint and Appaloosa breeds and up to \$25,000 for the Thoroughbred breed during FY 2022.

F. REMINGTON PARK'S REQUEST TO AMEND CY 2021 LIVE RACE DAYS FOR FALL THOROUGHBRED RACE MEETING.

On May 5th, 2021, Mr. Matt Vance, Vice President of Operations at Remington Park, requested Commission approval to amend its CY 2021 Fall allotted live race days for the Thoroughbred Race Meeting. TRAO jointly agrees with the request.

The requested changes are as follows:

- Eliminate December 1, 2, 8 & 9
- Add September 1 & 8
- Add November 15,16, 29 & 30
- Add December 6 & 7
