D. POSSIBLE ACTION ON PROPOSED RULE AMENDMENTS TO CERTAIN CHAPTERS IN RULES OF RACING AND RULES OF RACETRACK GAMING UNDER PERMANENT RULEMAKING

At the August 15, 2024, Commission Meeting, the Commission approved the permanent rulemaking process to consider proposed amendments to open certain chapters in *Rules of Racing and Racetrack Gaming* including Chapters 1, 15, 25, 60, 65, 70, 75, 80, 85, & 90.

The Rules Committee has additional worked on Chapter 45 and is proposing a change in that Chapter.

Current Consideration

To additionally, open Chapter 45 to consider proposed amendments. Thereafter, the next step in the rulemaking process is for the Commission to provide the Secretary of State proposed rule amendments in Chapters 1, 15, 25, 45, 60, 65, & 75 under the permanent rulemaking process, to publish the proposed changes, conduct a hearing, and take public comment.

Possible action may include, but is not limited to: take no action, opening Chapter 45 for permanent rule making, approving the beginning of the permanent rulemaking process to consider amendments in the cited chapters as proposed, or as modified at the meeting, by authorizing publication in *The Oklahoma Register*, scheduling a Public Hearing and take Public Comment; or continuing the matter.
