REGULARLY SCHEDULED MEETING JANUARY 24, 2019

MINUTES

CALL TO ORDER

Chairman Lucas called the Regularly Scheduled Meeting of the Commission to order at 9:30 a.m. in the Board Room of the Department of Agriculture, Food and Forestry, Oklahoma City, Oklahoma.

ROLL CALL

Commission members answering roll call were Commissioners Goumaz, Keener, Kirk, Marcum, Sanders, Von Hemel, Wiens, Wright and Chairman Lucas. The following Commission staff members were in attendance: Mr. Kelly Cathey, Mr. Pete Markstone, Ms. Shonna Gore, Ms. Kara Moore and Ms. Bonnie Morris. Approximately twenty people attended and signed the registry which is part of the record.

MINUTES

Commissioner Wiens made a motion to approve the drafted minutes of the November 15, 2018 Commission meeting as presented. Commissioner Sanders seconded the motion. The vote was recorded as follows:

APPEAL HEARING AND REFERRAL BY BOARD OF STEWARDS AT REMINGTON PARK ON THERONE TRENT ALEXANDER, OWNER/ TRAINER, IN STEWARDS' ORDER 18-RP-086

Background

In Stewards' Order 18-RP-086, the Board of Stewards at Remington Park found Mr. Alexander to be in violation of OAC 325:35-1-5(a), <u>Trainer Responsibility</u>, and OAC 325:35-1-21, <u>Tricks/Schemes Prohibited</u>, regarding his care of POPPIN BAYOU while the horse was undergoing training for the 2018 Remington Park Spring Quarter Horse, Paint and Appaloosa race meeting. The Board of Stewards imposed the maximum penalty within their authority of a Three Hundred Sixty Five Days [365] suspension, beginning Thursday, November 1, 2018 and continuing through Thursday, October 31, 2019.

The Board of Stewards referred the case to the Commission with the recommendation that the Commission instead, impose the greater penalty of revocation of Mr. Alexander's Owner/Trainer license. Mr. Alexander appealed the suspension.

Current Consideration

The Commission conducted an Appeal and Referral Hearing. Mr. Alexander represented himself. The Board of Stewards at Remington Park was represented by Mr. James Rucker, Deputy General Counsel, Department of Agriculture, Food and Forestry.

After hearing argument and evidence and asking questions, Commissioner Wiens made a motion to go into Executive Session to deliberate on the matters and include Ms. Sandra Balzer, Commission Legal Counsel, and Mr. Kelly Cathey, Commission Executive Director. Commissioner Keener seconded the motion. The vote was recorded as follows:

REFERRAL BY BOARD OF STEWARDS AT REMINGTON PARK REGARDING STEWARDS' ORDER 18-RP-097

Background

In Stewards' Order 18-RP-097, the Board of Stewards at Remington Park found Mr. Enlow to be in violation of OAC 325:45-1-11, <u>Trainer Responsibility</u>, regarding the Paint horse, RP LIVE WIRE DASH, under his care and custody testing over the listed threshold for the drug, DEXAMETHASONE, following the 6th race at Remington Park, the finals of the Oklahoma Paint and Appaloosa Horse Futurity, on March, 24, 2018. Mr. Enlow was fined \$500.00. He did not dispute the Stewards' finding of a medication violation or the imposition of the fine.

The matter before the Commission was whether any mitigating circumstances exist to merit imposition of a different penalty than the ARCI recommended disqualification of the horse and loss of purse.

Current Consideration

Commissioner Keener recused herself and left the meeting for this agenda topic.

The Commission conducted a Referral Hearing. Mr. Enlow represented himself and asked Dr. Billins to present argument and evidence. The Board of Stewards was represented by Mr. James Rucker, Deputy General Counsel, Department of Agriculture, Food and Forestry.

After hearing argument and evidence, Commissioner Goumaz made a motion to go into Executive Session to deliberate and include Ms. Sandra Balzer, Commission Legal Counsel, and Mr. Kelly Cathey, Commission Executive Director. Commissioner Sanders seconded the motion. The vote was recorded as follows:

Commissioner Von Hemel seconded the motion. The vote was recorded as follows:

JOINT REQUEST FROM WILL ROGERS DOWNS AND THE THOROUGHBRED RACING ASSOCIATION OF OKLAHOMA TO AMEND CY 2019 LIVE RACE DAYS FOR THE THOROUGHBRED RACE MEETING

In a December 3, 2018 letter, Ms. Danielle Barber, Executive Director of the Thoroughbred Racing Association of Oklahoma, and Mr. Mark Enterline, Consulting General Manager for Will Rogers Downs, requested amending the CY 2019 live race days for the Thoroughbred race meeting.

Specifically, the request was to amend the start date from Monday, March 18, 2019, to a week later on Monday, March 25, 2019 and to add two Wednesdays, March 27, 2019 and April 3, 2019. This would maintain the total of 28 live race days.

Commissioner Marcum made a motion to approve the request to change the CY 2019 live race dates for Will Rogers Downs's CY 2019 Thoroughbred live race dates. Commissioner Von Hemel seconded the motion. The vote was recorded as follows:

RECOMMENDATIONS FROM THE OKLAHOMA-BRED ADVISORY COUNCIL

<u>Thoroughbred Racing Association of Oklahoma's Funding Request for CY 2019</u> <u>Thoroughbred Stakes Races at Will Rogers Downs</u>

In a December 28, 2018 letter, Ms. Danielle Barber, Executive Director, Thoroughbred Racing Association of Oklahoma, requested that Oklahoma-Bred funds be added to the following six stakes races to be run during WRD's CY 2019 Thoroughbred race meeting with a payout percentage breakdown of 60/20/11/6/3, totaling \$60,000 subject to availability of funds at the time the races are conducted as follows:

The Oklahoma-Bred Advisory Council unanimously recommended \$60,000 in funding from the Oklahoma Breeding Development Fund Special Account for the six listed stakes races subject to availability of funds at the time the races would be conducted.

Commissioner Von Hemel made a motion to approve the Oklahoma-Bred funding request for the six CY 2019 stakes races to be run at Will Rogers Downs. Commissioner Wiens seconded the motion. The vote was recorded as follows:

Thoroughbred Racing Association of Oklahoma and Fair Meadow at Tulsa's Funding Request for CY 2019 Thoroughbred Stakes Races to be Conducted at Fair Meadows at Tulsa

In an December 28, 2018 letter, Ms. Danielle Barber, Executive Director of the Thoroughbred Racing Association of Oklahoma, requested a total of \$20,000 in added Oklahoma-Bred funding for two stakes races to be conducted during Fair Meadows at Tulsa's CY 2019 race meeting with

the payout percentages at 60/20/11/6/3 subject to availability of funds at the time the races are conducted as follows:

The Oklahoma-Bred Advisory Council unanimously recommended \$20,000 in funding from the Oklahoma Breeding Development Fund Special Account for the two stakes races.

Commissioner Marcum made a motion to approve the Oklahoma-Bred funding for the CY 2019 two stakes races at Fair Meadows at Tulsa. Commissioner Von Hemel seconded the motion. The vote was recorded as follows:

DISTRIBUTION OF BREAKAGE AND UNCLAIMED TICKET PROCEEDS GENERATED OUTSIDE OF A RACE MEETING

Background

At the May 18, 2017 Commission meeting, a hearing was held to address the distribution formulas being applied for breakage and unclaimed ticket proceeds generated outside of race meetings [Item F.1]. Both the OQHRA and TRAO were represented by Attorneys, which provided the Commission with briefs and oral arguments on the matter. The Board ruled the distribution formula to be 90 percent to Thoroughbreds and 10 percent to Quarter Horses, Paints and Appaloosas at Remington Park and Will Rogers Downs, effective January 1, 2017, and no change in the distribution formula for Fair Meadows at Tulsa. On October 30, 2018, the District Court of Oklahoma County voided said order based upon a procedural consideration.

Current Consideration

Because the Commission's May 18, 2017 order was voided by the District Court, the Commission would readdress the matter involving the distribution of breakage and unclaimed ticket revenue that remains in question.

Commissioner Keener made a motion to go into Executive Session to deliberate on the matter and include Mr. James Rucker, Deputy General Counsel, Department of Agriculture, Food and

Section 204, and interpreting OAC 325:75-1-15(b), to move that this calculation be used in the distribution of breakage and unclaimed ticket proceeds generated outside of a race meeting is 90% Thoroughbred and 10% Quarter Horse, Paints and Appaloosas at Remington Park and at Will Rogers Downs and 42% Thoroughbred, 42% Quarter Horse and 16% Paints and Appaloosas at Fair Meadows at Tulsa effective as of January 1st 2011 and direct Commission Counsel to draft an Order for consideration at the February 21, 2019 meeting. Commissioner Wright seconded the motion. The vote was recorded as follows:
