### A. MINUTES

B. MONITORING OF COMPULSIVE GAMING ASSISTANCE PLANS
BY RACETRACK GAMING OPERATOR LICENSEES AS
REQUIRED IN RULES FOR RACETRACK GAMING.

Chairman Keener announced the agenda item and gave the floor to Executive Director Cathey who informed the Commission that Dr. Harwell would not join us until later in the year. Mr. Cathey called attention to the Annual Status Report submitted to the Commissioners by way of their packet. Mr. Cathey asked if there were any questions.
