# C. PETITION FOR DECLARATORY RULING FILED ON BEHALF OF AUSTIN GUSTAFSON (OWNER/TRAINER), JUAN PULIDO (JOCKEY), AND FELIPE MARTINEZ MORALES (OWNER/TRAINER)

On October 22, 2021, the Commission received a Request for Declaratory Ruling filed by Attorney John Mac Hayes. Pursuant to Commission rule OAC 325:1-1-18 Mr. Hayes seeks a declaratory ruling on the applicability of 75 O.S. § 316 to the members of the Board of Stewards at Remington Park. Section 316 concerns the disqualification of an agency member for inability to give a fair and impartial hearing.

It was noted by OHRC Administrator, Kelly Cathey, that Mr. Long (Stewards Legal Counsel) was not able to be present at the meeting and that his argument is presented in the brief provided.

Vice Chairman Keener motioned commission recognizes the stewards authority under 75 OS Section 316 to determine best qualifications for Remington Park Board of Stewards. Commissioner Anderson seconded the motion and the vote was as follows:
